Advancing Our Strategic Plan

THE POWER OF PARTNERSHIPS

Grow Bancroft

Bancroft has successfully completed the third year of our strategic plan, achieving a remarkable \$60 million increase in revenue primarily through organic growth. As we proceed with our strategic plan, we are on target to reach \$100 million in growth by 2026. This substantial expansion will enable us to better meet the increasing demand for services for individuals living with disabilities.

Clinical Partnerships

This past year, Bancroft has continued to build on our clinical partnerships, which will assist us in delivering outstanding outcomes for each person we support – and contribute to best practices in treatment. These partnerships are instrumental in driving clinical excellence, a key pillar of our strategic plan.



Bancroft and Cooper University Health Care are united in their commitment to delivering exceptional healthcare to individuals with intellectual disabilities and autism. Through our partnership, we are introducing a mobile clinic that will bring high-quality medical care directly to Bancroft programs. This innovative mobile clinic will feature a team of physicians and necessary medical resources, providing on-site care to enhance the well-being of individuals with disabilities. By merging our expertise and dedication, we are advancing best practices and pioneering new care approaches.



In partnership with Senacare, primary care and psychiatry services have been brought onsite to select Bancroft residential campuses. The team-based approach has streamlined care coordination, improved the quality of care, and reduced emergency room utilization and the need for off-campus appointments. The goal is to expand the program to additional campus settings and add mobile clinics that visit adult day programs, reaching as many individuals as possible and offering the highest level of comprehensive care.



Bancroft and A.J. Drexel Autism Institute share a vision to lead the industry in best practices for treating profound autism. Together, we are developing behavioral, healthcare and mental health treatments to meet the growing needs of those in our care. Over the next year, we will be implementing a social skills intervention to improve quality of life and growing an outpatient diagnostic and treatment clinic.



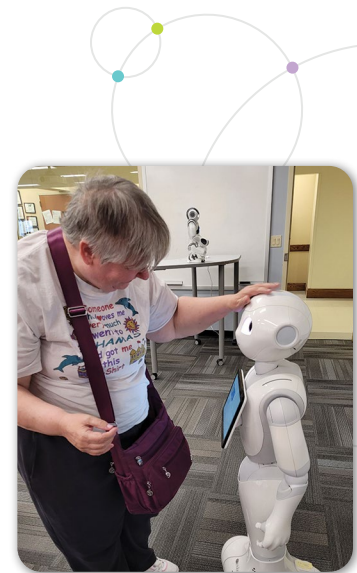
Bancroft has partnered with the Haub Innovation Center at St. Joseph's University to leverage new technologies for individuals in our programs. Bancroft's Flicker residents have a new friend in Iggy, an AI-powered humanoid robot developed by researchers at St. Joseph's University. This partnership is designed to support individuals with disabilities and their caregivers. Iggy provides entertainment, education, information and general assistance. This ongoing study aims to unlock the potential of robotic aids for people with cognitive and physical disabilities, with the vision that Iggy is part of an ecosystem that can engage, recognize needs, hold data on individual care plans and assist care teams.

Bancroft and Rowan University are partnering to develop a *Center for Inclusive Wellness* that will provide a centralized place to create and disseminate evidence-based interventions centered on health and wellness. This year, we implemented inclusive gardens and cooking classes at several residences, with plans to expand these programs. Leveraging the University's talent, interventions will be developed to better support the individuals we support and to foster a culture of wellness for those in our care and Bancroft employees.



New Technology Partnerships

Bancroft is harnessing technology through new vendor partnerships to optimize our operations and improve processes, leading to cost savings, better resource allocation and a deeper fulfillment of our mission. By fortifying our infrastructure, we aim to enhance care, address workforce shortages and streamline our operations. Over the past year, Bancroft has introduced systems for financial management, workforce management and human resources. We are also collaborating with Core Solutions to implement a new electronic health record (EHR) system. This EHR will enable providers to make more informed decisions, reduce medical errors, and improve coordination between providers and families.

PARTNERING WITH DONORS

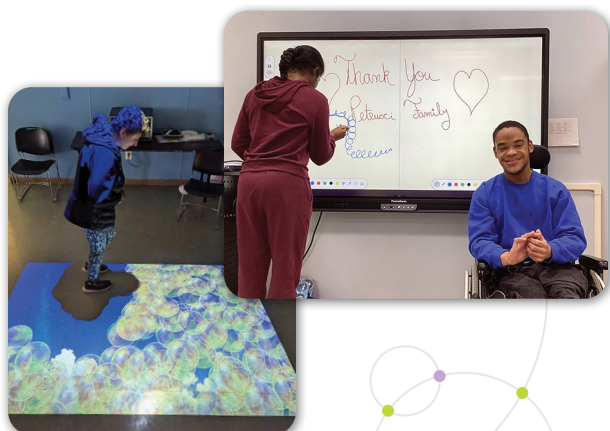

The powerful impact of some of our partnerships with individual donors, corporations and foundations over the last year is inspiring.

Innovative Technology

Innovative technology significantly enriches the lives of the individuals in Bancroft's care and empowers them to achieve greater independence, engage more fully in their community and reach their full potential. With donor support, we were able to intersect emerging technology with compassionate support into our programs.

- Meet Budii! Budii is an interactive projector that increases cognitive engagement, socialization and physical activity for the individuals supported at the Jacob Schaefer Center.
- Promethean Panels offer a variety of applications for group and individual engagement, ranging from educational programming, such as art and music lessons, to recreational activities, such as yoga and global field trips.



Enrichment and Community Outings

Enrichment activities and community outings have a profound impact on the individuals we support by fostering social inclusion, enhancing personal development and improving overall well-being.

- Trips to The Funplex, sporting events, the theatre and more – many Bancroft families have helped establish engagement and activities funds for their loved one's residence or program.
- Everyone deserves to feel loved and celebrated on their special day! Thanks to the donors who support the Giving Spirit Fund, individuals in our care without family involvement receive a birthday and holiday gift.

Sensory Rooms

Sensory rooms are designed to address the unique needs of children and adults with disabilities, offering a variety of physical, emotional and cognitive benefits. These environments help individuals process and regulate their feelings and emotions in a controlled and safe setting. With corporate and individual donor contributions, we improved the sensory experience in two programs.

- Our littlest learners at the Preschool & Early Education program have a newly enhanced sensory space featuring giant bean bags, wall bubbles, calming touch walls, and fiber optic lights for visual and tactile stimulation.
- Bancroft's Beckett Day program will have a state-of-the-art sensory room with bubble tubes, rainfall panels, a soft cushioned and vibrating chair, soothing lights and sounds, and so much more!



Enhanced Programming

Philanthropy and strategic partnerships enable us to enhance our programs and services, including educational, recreational, social and therapeutic activities. Without donor support and collaborative partners, many of these advancements would be out of reach.

- Residents in our Delaware program are connecting with nature and planting vegetables, herbs and flowers in their new vegepods. Gardening can have many health benefits for individuals with disabilities and provide an excellent source of stimulation, relaxation and connection.
- Bancroft's partnership with the Perkins Center for the Arts continues to blossom with individuals from some of Bancroft's Adult programs engaged in an exploration of the arts, including cooking and baking, pottery, drawing and painting, and mural arts.

BANCROFT FAMILY STORY

Nurturing Potential Through Partnerships



When Ellie was born, her first-time mother Peg sensed something was wrong. Within months, her intuition was confirmed as Ellie missed key developmental milestones and appeared disconnected from her surroundings. After numerous appointments, Peg and her husband Jim were told that Ellie might just “need time to catch up.”

Peg and Jim struggled with denial about Ellie’s differences until they enrolled her in a special needs class, where seeing other children of the same age surpass her in development shattered their denial. Peg described it as a painful realization. At age three, Ellie was diagnosed with autism, followed by epilepsy.

As Ellie grew older, her epilepsy was controlled, but her behaviors worsened, leading to self-injury by age 11 or 12. Despite her small size, Ellie caused significant harm, forcing Peg and Jim to baby-proof their home. Although they had vowed not to place Ellie in residential care, the severity of the situation made them reconsider for the safety of their family.

After researching extensively, they were quickly drawn to Bancroft. The brand-new Raymond & Joanne Welsh Campus gave them a sense of peace and belonging. From their first visit, they felt Bancroft could be the partner they needed and where Ellie would be safe, thrive and grow.

Peg and Jim learned Ellie was accepted into Bancroft’s Lindens program – their ideal option as it offered 24/7 nursing for her seizures.

In November 2018, Peg and Jim packed Ellie’s belongings and drove from North Jersey. Though terrified to leave her with strangers, Peg felt a level of trust and allyship from the Lindens team. Ellie’s placement at Bancroft allowed Peg and Jim to prioritize their marriage. They slowly adjusted to their “new normal.”

Within the first year, the Bancroft team made remarkable progress with Ellie, reducing her medications and her dangerous behaviors. By early 2020, she transitioned to The Bancroft School, and in 2021, she moved to the Campus Residential Treatment program.

After two years on campus, the Bancroft team suggested Ellie move to a community-based home. Though initially skeptical, the team’s confidence reassured Peg and Jim.

Now 20, Ellie thrives in her home and attends The Bancroft School. She has a close bond with her Direct Support Professional (DSP), Jessica, who says Ellie finds humor in everything. Ellie loves music and sounds, especially bird sounds, and enjoys being outdoors and playing in the leaves.

Ellie now has a maturity about her that her family wasn’t expecting. Peg shared a story about a time when another DSP was having a bad day and began to cry. “Ellie got off her bed and went over to her and knelt down in front of her, took her hands and started kissing her hands. That absolutely floored me. That awareness of another human being and that show of compassion, that moment just really gives me a lot of hope for Ellie’s future.”

Member Spotlight

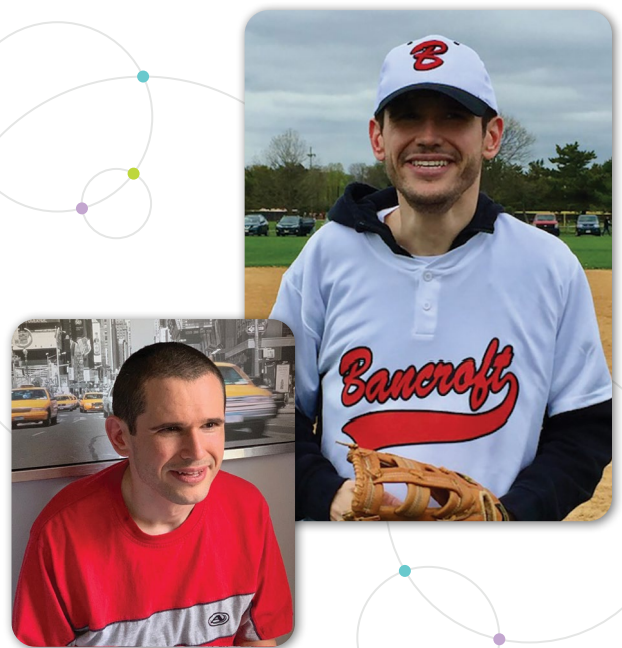

We had no way of knowing how hard everyone responsible for Michael's education, social life, care, and support would work to help him achieve what we all believed was possible for Michael to accomplish. Michael also worked very hard every step of the way, and for that we are enormously proud of him.

He loves playing games and reading his favorite books on his iPad, and when we read to him, he smiles with such joy. We clearly recognize that none of this would have been possible without Bancroft's unwavering commitment to improving the overall quality of Michael's life.

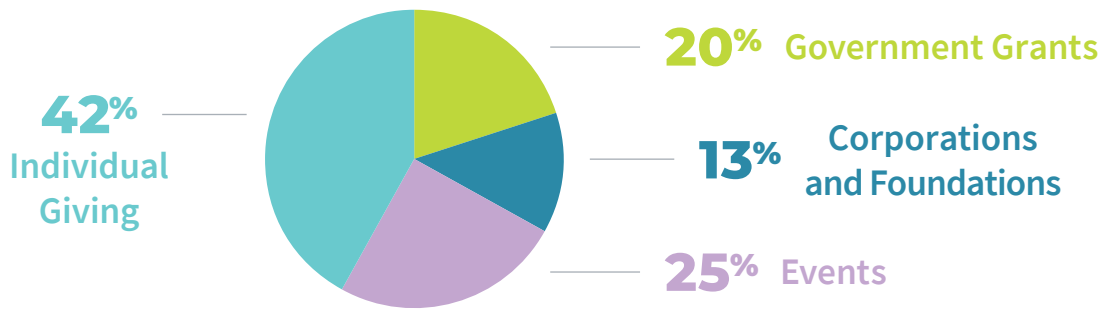

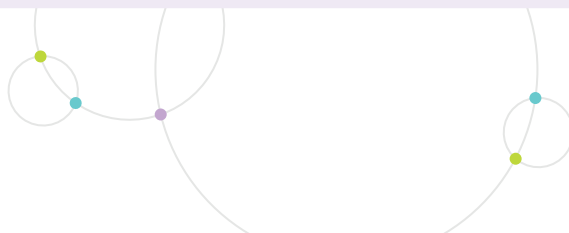
